3. Vendors are responsible for all trash generated within their booth area.
4. Setup times and assigned locations will be coordinated by the event committee.
5. No alcohol sales are permitted without proper licensing and written approval.
6. Friends of the Depot reserves the right to refuse or revoke vendor participation.
7. Vendors are responsible for complying with all local, county, tribal, state, and federal regulations.
8. All food vendors must comply with Big Horn County Environmental Health requirements.
9. Vendors participate at their own risk.
10. Refunds will not be issued within 10 days of the event.
